### **COMMUNIQUE ISSUED AT THE EMERGENCY MEETING OF THE BOARD OF TRUSTEES NAPPS NIGERIA TO ADDRESS THE CURRENT CRISES ROCKING THE ASSOCIATION CAUSED BY THE CONVOCAION OF A NATIONAL DELEGATES CONFERENCE OF OCTOBER 23, 2023 IN ABUJA.**

The Board of Trustees NAPPS Nigeria Chairman, led eight other members to an Emergency Meeting today, 6th day of November 2023 to address simmering urgent matters capable of destroying the very foundation of the Association following the convocation of an illegal National Delegates Conference on October 23, 2023 after the Board had in an earlier Memo advised the National Executive Council against holding the meeting.

#### **NATIONAL DELEGATES CONFERENCE**

The Board was miffed at the unnecessary militarisation of the venue of the purported National Delegates Conference which created panic among members as well as the total conducts of the meeting.

The Board, noting that nothing could be built on nothing declared in unequivocal term that the act of holding the meeting was illegal since it was against the Board's directive, hence all decisions, pronouncements, proclamations and actions taken at the purported National Delegates Conference was declared null , void and lacks any effect.

For avoidance of doubts, the purported Amendments of the 2017 Constitution , Convocation of Electoral Committee, removal of Prince Sakiru Adesina Raji and Hon. Awa, Augustine Kala by voice proclamation as Trustees of NAPPS Nigeria is invalidated, void and inconsequential.

#### **BORROWING WITHOUT RECOURSE TO THE BOARD**

As the Custodians of the Association, the body was surprised and taken aback that the NEC went out to borrow money from undisclosed sources without her consultation or consent and directed that all documents, receipts and other relevant materials relating to the said transactions should be made available to it.

All monies, properties both movable and unmovable are entrusted to the Board hence no such transaction could be lawfully done without the knowledge and approval of the Body.

## **PETITION OF THE NATIONAL TREASURER, CHIEF ARUGWU ANDERSON**

The petition of the National Treasurer, Chief Arugwu Anderson in which he alluded to the fact that he is sidelined in the financial and monetary matters of the Association since 4 years ago did not escape the torchlight of the Board.!!!

He listed 8 different accounts of the Association to which he never knew when they were opened or how they are being managed.

The Board frowned at this financial voodoo and therefore directed that the financial records of the Administration be scrutinized by External Auditors and if need be, the Board should invite ICPC to do the needful.

## **FIRST CITY MONUMENT BANK CONCESSIONARY LOAN**

Following the disclosure by the National President that FCMB had purportedly given loans of over N10billion to members nationwide, the Board was shocked that the Association could not boast of a gain of a dime from the Bank or the Consultant.

The Board therefore requested the National Executive Council, NEC to present it with the Memorandum of Understanding signed with the Bank and the Body on one hand and the Consultants on the other.

## **SANCTITY OF NOVEMBER 22 2023 AS THE DATE OF HANDING OVER AFTER 4 YEARS**

The Board unanimously agreed that the terminal date for the current NEC to vacate office is November 22, 2023.

However, because the Administration failed to uphold the sanctity of the letter titled **RE: REVIEW/ RECOMMENDATIONS MADE BY THE COMMITTEE ON NAPPS CONSTITUTION AMENDMENTS** of August 27, 2023 which directed the NEC to stop the proposed National Congress but which it ignored; need to prevent Administrative lacuna and fulfilling in all righteousness the dictate of the NAPPS Constitution which stipulates only 4 years and not a day longer, the Trustees decided to enforce the **Doctrine of Necessity** by directing that the National President hand over to the Board of Trustees through its Chairman to constitute itself into NAPPS Caretaker Committee to fashion out Election Timetable, hold election and ensure that new National Officers are sworn in for another four years.

The time frame is within 3 months and maximum 6 months.

## CONCLUSION

The Chairman, Dr Sai'du Mijinyawa and Members of the Board of Trustees are resolute and committed to uphold the sanctity of the Association's Constitution what come may.

We wish to request all members to commit NAPPS Nigeria to God Almighty in prayers to lead us and elect for us a new NEC that will continue to keep our flags flying higher and higher.

We appeal to all lovers of NAPPS Nigeria to please sheath the swords and believe in the Board to birth a New NAPPS.


